Help Us Spread the Word... I Steer Clear



AAA Foundation reports, "Fatal crashes involving drivers who recently used marijuana doubled in Washington after the state legalized the drug, according to the latest research by the AAA Foundation for Traffic Safety. New research also shows that legal limits for marijuana and driving are arbitrary and unsupported by science, which could result in unsafe motorists going free and others being wrongfully convicted for impaired driving." With medical Marijuana just passing in the State of Florida, the need to be proactive to possible increases in driving impairment is necessary.

Impaired driving is an on-going problem throughout the nation. In the State of Florida, there were 16,400 alcohol-related suspected crashes and 1,990 drug suspected crashes in 2015, (Florida Department of Highway Safety and Motor Vehicles). In 2015 in Hernando County, there over 100 alcohol crashes. In 2014, there were nearly 300 DUI arrests in the county per the Florida Department of Law Enforcement. In 2016, 15.4% of Hernando County high school students reported riding in a car with someone who had been drinking and 23.6% riding in car with someone under the influence of marijuana in the past 30-days, (Florida Youth Substance Abuse Survey). In the 2014/2015 Community Teens Norm Survey, 12% of high school students reported driving a car after drinking. Of the youth who reported riding in car with someone who had been drinking, more youth reported riding with a family member than a friend. In January and February of 2015, the Coalition partnered with the District's DUI school to survey Hernando offenders on if they were under the influence of drugs the day of the arrest. 8% reported they had used marijuana and 4% used prescription narcotics.

2017 Mental Health First Aid Trainings

MHFA is an 8 hour public education course that introduces participants to the risk factors and warning signs of mental illnesses; including anxiety, depression, substance use, bipolar disorder, eating disorders, and schizophrenia, builds understanding of their impact, and provides and overview of common supports. Participants who have attended and received their certifications as "Mental Health First Aiders" have stated to have learned new techniques to stay calm in offering aid to someone who is living with a mental health disorder, to not have judgment, the link between tobacco use and mental health illness.

COSTS AND CONSEQUENCES OF NONMEDICAL OPIOID USE IN FLORIDA

Exerts from the Statewide Policy Advisory Council 2016 Annual Report

Since 2000, the rate of deaths from drug overdoses has increased 137 percent, including a 200 percent increase in the rate of overdose deaths involving opioids (opioid pain relievers and heroin). In Florida, 1,967 deaths were caused by at least one opioid in 2014. This means that at least five lives per day are lost to opioid overdose in Florida.1 The number of deaths in 2014 caused by motor vehicle crashes (2,402) and firearms (2,375) were less than deaths caused by prescription drugs, illicit drugs and alcohol detected in 8,587 decedents.

Total societal costs of prescription opioid abuse in the United States were estimated at \$55.7 billion in 2007 (with workplace costs accounting for 46 percent, health care costs accounting for 45 percent, and criminal justice costs accounting for 9 percent).5 Prescription opioid overdoses result in 830,652 years of potential life lost before age 65.

In 2011, there were 1,563 instances of newborns diagnosed with drug exposure in Florida, a three-fold increase since 2007 – and neonatal abstinence syndrome (NAS) is still widely believed to be an under reported problem. NAS is a postnatal drug withdrawal syndrome in newborns caused primarily by in utero exposure to opioids. Between 2010 and 2015, the number of cases of NAS in Florida have increased by 86 percent (from 1,336 to 2,487)

The prescription drug abuse epidemic is fueled in part by a minority of prescribers who over-prescribe or otherwise deviate from standards of practice. Prescribers who deviate from accepted standards of practice or whose prescribing is unusual or uncharacteristic for their specialty are considered at-risk prescribers.11 In Florida, the top 10 percent of prescribers account for approximately 64 percent of all prescribing.

The "Power" of SWAT Making a Difference in our County A "Snap Shot"

Hernando Community Coalition's Students Working Against Tobacco (SWAT) program continues to thrive and grow in their efforts to advocate a consistent message among Hernando County community members from community events, outreach meetings, in school activities, and trainings.

2017 began with our county's state Youth Advocacy Member (YAB), Emma Buscemi; representing our region in collaboration with 3 other members from Osceola, Seminole, and Manatee County, as well as SWAT Coordinator, Jennifer Bliska, at a statewide Youth Advocacy Board retreat from January 27-29th. The youth and coordinators worked together to record a new state SWAT video soon to be released on the state SWAT website, worked as a team on selected tasks and committees in planning the future SWAT state events and activities, brainstormed themes for upcoming state calls and presentations, as well as networked to increase SWAT engagement and energy to then bring back to each of their perspective counties.

As a result, a state-wide SWAT weekend training was then approved and two youth from Hernando County will have the opportunity to attend this upcoming June 9-11th training with YAB, and join other SWAT youth from ALL of the state's counties- an exciting way to learn and attain information to bring back to Hernando County for continued impact on anti-tobacco messaging!





Besides each of our ten schools coordinating their own continuous anti-tobacco messaging events and activities, all ten school SWAT clubs participated in February's "Through with Chew" week, a national activism effort to spread the message on the dangers of smokeless tobacco; including chew and snuff, which this year was February 19-25th. SWAT youth and advisors facilitated and coordinated a variety of events and activities within their schools raising awareness specifically on the negative effects of smokeless tobacco. A few of these events included interactive games during lunches, educational tables at school sporting events with trivia games during game intermissions, and SWAT youth posting informational posters throughout the schools depicting statistics on the dangerous effects smokeless tobacco.

SWAT youth, advisors, and SWAT Coordinator have been highly active within the community collaborating with the Hernando County Library's 5k run and Kids fun run event, the county's reading festival, a Walk and Roll 5K event for disability awareness sponsored by the Hernando County School District's Exceptional Student Support Services with Habitat for Humanity, and the American Cancer Society with their upcoming Spring Hill Relay for Life team themed, "Green Eggs and Ham, Tobacco Free I Am!"



In addition, SWAT youth, advisors, and SWAT Coordinator will be coming together in April to begin planning for the 2017-18 school year with plans on maintaining capacity and reaching above and beyond next year and taking the next step to host a regional event for surrounding counties to participate. The continuous work, efforts, and dedication to the SWAT mission is what continues to drive HCC's SWAT program resulting in the continuous **"Power of SWAT"**.
